Opening Keynote – Dr. Stephen James, Ph.D

Dr. James is a leading researcher in how fatigue, stress, and operational realities affect performance in law enforcement and military environments. He's worked globally with agencies—and his keynote will spotlight how data and science are being used to improve officer wellness, performance, and public safety outcomes.

Command staff and risk pool executives will learn proven implementation strategies that elevate agency performance as measured by fewer officer injuries, lower turnover and reduced liability risk. The panel discussion will cover practical tactics to overcome resistance, change habits, and build accountability systems that deliver measurable claim reductions.

Scaling Risk Management Programs with Regional Excellence Networks
